

CONTACT WITH COMPETENT AUTHORITIES AND NOMENCLATURES

In addition to the legal bases that ensure the protection of children and adolescents, you need to be familiar with the role of the so-called bodies that protect and guarantee the rights of children and adolescents. They are:

TUTELAR COUNCIL (CT) (*Guardianship Council*): an autonomous, administrative body of five members elected by the community that operates in the municipal context. This Council is responsible for dealing with cases of children who have been threatened or whose rights have been violated and can apply protective measures with the force of law, as laid down in the Statute of the Child and Adolescent (ECA).

SPECIALISED DELEGATION: a civil police body responsible for investigating cases involving child victims. Unfortunately, not all cities in the country have this type of police station. In cities where there are no specialised police stations, the Civil Police Station should be contacted.

PUBLIC MINISTRY (MP): the body responsible for enforcing laws. Its prosecutors become strong allies in social causes, such as defending children's rights.

PUBLIC DEFENCE OFFICE: a state body that aims to provide free legal assistance to anyone who needs it by appointing public defenders or lawyers.

JUSTICE FOR CHILDREN AND YOUTH: the judicial body responsible for applying the law to resolve conflicts related to the rights of children and adolescents.

DISQUE 100: is an anonymous reporting channel that is an essential tool in tackling violations of children's and adolescents' rights. It is open 24 hours a day, including Saturdays, Sundays, and public holidays. Calls can be made from all over Brazil via free dialling from any land or mobile telephone terminal. You can download the app 'Aplicativo Direitos Humanos BR', which is Dial 100's digital platform. It's free, anonymous, and secure.

Ministry of Human Rights of the Presidency of the Republic: the federal executive body responsible for articulating and implementing policies and guidelines aimed at promoting and protecting human rights. It works in partnership with other federal agencies, states, municipalities, and civil society institutions. Anyone can report rights violations via Dial 100.

CONANDA - National Council for the Rights of Children and Adolescents is the main body in the system that guarantees the rights of children and adolescents. Through shared management between government and society, it aims to coordinate actions to promote, protect and defend the rights of children and adolescents. Through the city's Guardianship Council, cases can be brought that involve contentious, contradictory or conflict of interest issues, such as suspension or dismissal of family power, removal of the child or adolescent from the company of their parents, definitions of Guardianship, Guardianship and Adoption.

Superior Labour Court/National Council of Labour Justice (TST/CSJT) - a government body that conciliates and judges lawsuits between workers and employers and other disputes arising from the employment relationship, as well as claims arising from the enforcement of its sentences, including collective ones. Claims that can be made: recognition of rights (annotation on the wallet, for example) and payment of amounts that the company refuses to pay (such as an unhealthy work bonus or double holiday pay).
